2.2. Vendor guarantees that this PO takes precedence over and replaces all other project documentation.

2.3. Prior to delivery of any product/services, the Vendor shall, at its own expense, carry out site inspections and/or tests as necessary to ensure that they comply with the conditions stated in Clause 1, upon which Intelligent Design shall rely.

2.4. Vendor certifies that the services/products rendered via this PO shall be provided with reasonable skill and care to the appropriate professional standard and to the satisfaction of Intelligent Design.



2.5. Vendor certifies that products/services shall be of satisfactory quality and free from defects in provision, design, materials and workmanship.

2.6. Vendor shall meet the description of any agreed sample and otherwise conform to any specification given.

2.7. The Vendor certifies that the products/services shall be fit for any such purpose made known by Intelligent Design to the Vendor, and in this respect, relies on the Vendor's skill and judgment.




